Notice is hereby given that by an Order dated 12 December 2019, the Mumbai Bench of the National Company Law Tribunal (the 'NCLT') has directed the First Applicant Company to issue notice **to the sole unsecured creditor of the First Applicant Company** under the



provisions of Section 230(3) of the Companies Act, 2013 with a direction to submit their representation, if any, in connection with the matter of Scheme of Merger by Absorption of Milestone Signage Solutions Private Limited and Storyboard Brandcom Private Limited by Milestone Brandcom Private Limited and their respective shareholders (the 'Scheme') and that the meeting of the unsecured creditors of the First Applicant Company has been dispensed with by the NCLT.

In case no representation is received within the stated period of 30 (Thirty) days, it shall be presumed that you have no representation to make on the Scheme.
