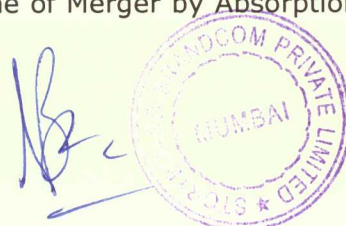

**NOTICE TO CENTRAL GOVERNMENT, REGULATORY AUTHORITIES**

Notice is hereby given that by an Order dated 12 December 2019, the Mumbai Bench of the National Company Law Tribunal (the 'NCLT') has directed the Second Applicant Company to issue notice to **all the unsecured creditors of the Second Applicant Company** under the provisions of Section 230(3) of the Companies Act, 2013 with a direction to submit their representation, if any, in connection with the matter of Scheme of Merger by Absorption of



Milestone Signage Solutions Private Limited and Storyboard Brandcom Private Limited by Milestone Brandcom Private Limited and their respective shareholders (the 'Scheme') and that the meeting of the unsecured creditors of the Second Applicant Company has been dispensed with by the NCLT.

Further, in pursuance of the said Order and as directed therein, the meeting of the Equity Shareholders of the Second Applicant Company has been dispensed with by the NCLT, in view of the Additional Affidavit dated 19 September 2019 in support of Company Application as filed with the NCLT, inter alia stating therein that there are only 2 shareholders holding equity shares in the Second Applicant Company and that the Second Applicant Company having procured the written consent affidavits from all its Equity Shareholders.

You are hereby informed that representations, if any, in connection with the Scheme, may be made to the National Company Law Tribunal, Mumbai within 30 (Thirty) days from the date of receipt of this notice. Copy of the representation may simultaneously be sent to the Second Applicant Company at its registered office.

In case no representation is received within the stated period of 30 (Thirty) days, it shall be presumed that you have no representation to make on the Scheme.

By virtue of the said order, the Tribunal has appointed M/s. Madhusoodan Kakkad, Chartered Accountants to scrutinize the books of accounts of Storyboard Brandcom Private Limited and other Applicant Companies required to intimate the Official Liquidator in respect of the Scheme at a remuneration of Rs.1,50,000/-. Hence, we request your office to issue appointment letter accordingly at the earliest.
