Notice is hereby given that by an Order dated 12 December 2019, the Mumbai Bench of the National Company Law Tribunal (the 'NCLT') has directed the Third Applicant Company to issue notice to **all the unsecured creditors having an outstanding of Rs. 1,00,000/- and above of the Third Applicant Company** under the provisions of Section 230(3) of the Companies Act, 2013 with a direction to submit their representation, if any, in connection

In case no representation is received within the stated period of 30 (Thirty) days, it shall be presumed that you have no representation to make on the Scheme.
